Council 4th Monday Tax Bills

Lyndon property owners on record as of January 2021 will receive a bill from the city the first week in July. Owners who have their taxes paid from mortgage escrow accounts will not receive a bill but can request a copy at any time. The bottom of your tax bill will show three amounts. (see sample bill below) The first amount is a 10% discount due by August 1st. If not paid by August 1st, the second amount (gross amount) is due by October 1st and the last amount is a delinquent amount due by November 1st. When mailing in your payment, please insert the small stub (right side of tax bill) with your check. You may note the Parcel ID # on your check.

We urge you to mail in your tax payments or utilize our online payment service. If you choose to drop off payments at City Hall, place your payment in the black mailbox next to the front or back door. City Hall offices will continue to operate on temporary hours starting July 6th, Monday-Wednesday from 8:00 am to 3:00 pm until further notice. If you choose to pay online, we accept Master Card, Visa, Discover, American Express and electronic checks. You may access a link to the payment service on our website at www.cityoflyndon.org . There is a convenience fee of 2.5% for credit cards, 1.5 % for debit cards and \$1.50 for electronic checks.

Robsion Park Splash Pad and Pavilions

We are excited to have our splash pad open again and pavilions available for rent after a long year of Covid restrictions and cancelations. We know how important these amenities are to those who love the park and as always want to keep them clean and safe. Here are a few rules and regulations for our splash pad:

- Operational Hours: 9am 8pm
- Splash pad may be closed at any time due to weather, maintenance or other operational concerns.
- Splash Pad is unsupervised.
- All children under the age of 10 must have adult supervision.
- Toddlers must wear swim diapers.
- Patrons engaging in horse play or foul language will be asked to leave.
- Climbing on the splash pad features is strictly prohibited.
- Keep glass containers, bicycles, skateboards and in-line skates off the splash pad.
- No food or drink on the splash pad.
- No pets allowed on splash pad.
