COUNCIL MEETING MINUTES  
MONDAY, JUNE 26, 2017**

A motion was made by Kelly Kramer, seconded by Camie Popham to approve the minutes of the May 22, 2017 MRAP Hearing minutes. Motion carried unanimously. A motion was made by Betsy Kramer, seconded by Becky Ricketts to approve the June 19, 2017 Caucus Meeting. Motion carried unanimously.

**ORDINANCE #6-26-17- 1<sup>st</sup> Reading – Case No. 16ZONE1082- Zoning change from R-4 to R-6 at 911-913 Ormsby Lane-** A motion was made by Kelly Kramer, seconded by Betsy Kramer, to have City Attorney, John Singler give a 1st reading by summary of Ordinance 6-26-17. Motion carried unanimously. Mr Singler gave the first reading. Representatives Rob Sweet from McBride Dale Clarion and Marv Blomquist from Blomquist Design Group were in attendance and answered council questions. Discussion was held. **MUNICIPAL ORDER #6-26-17A – Grant Application** – A motion was made by Kelly Kramer, seconded by Carla Nalley to approve the grant application in the amount of \$10,000 from SeniorCare Experts. Council Member, Becky Ricketts, filed a financial disclosure statement and recused herself from the vote because she is an employee of SeniorCare Experts. Motion carried unanimously.


**ADJOURNMENT:**
