## CITY OF LYNDON COUNCIL MEETING MINUTES MONDAY, NOVEMBER 26, 2018

Mayor Brent Hagan called the Council Meeting to order at 6:00 p.m. The Pledge of Allegiance was recited. Those present: Dustin Gilchrist, Betsy Kramer, Kelly Kramer, Carla Nalley, Camie Popham, Becky Ricketts, Mardy Sidebottom and City Attorney John Singler. Guests were also present.

A motion was made by Becky Ricketts, seconded by Betsy Kramer to approve the minutes of the October 22, 2018 Council Meeting. Motion carried unanimously. Motion made by Kelly Kramer, seconded by Carla Nalley to approve minutes from November 19, 2018 Caucus Meeting. Motion carried unanimously.

The Treasurer's Report was given and will be filed for audit. Balance for November 1, 2018 was \$3,513,796.92.

**MUNICIPAL ORDER #11-26-18** - Agreement with MSD to purchase property on Ormsby Lane for 1/3 (\$45,000) of sale price \$135,000. Council members asked a few questions, discussion was held. A motion was made by Becky Ricketts, seconded by Carla Nalley. Motion carried unanimously.

**MUNICIPAL ORDER #11-26-18A** – Authorizing Mayor to enter into a Uniform Franchise Agreement with Verizon- A motion was made by Kelly Kramer, seconded by Betsy Kramer. Motion carried unanimously.

Betsy Kramer apologized for not attending the Jefferson County League of Cities dinner.

The Mayor announced the Council Meeting for December will be the 17<sup>th</sup> at 6:00pm in place of the Caucus. He also informed current council and new council member Amy Stuber, who was in attendance, of the City Officials Academy on January 16<sup>th</sup> through the 18<sup>th</sup> in Lexington. Ms. Ricketts, Ms. Nalley and Ms. Stuber committed to going.

Carla Nalley suggested the City talk with YMCA about the Turkey Trot next year. She stated her neighbors did not receive any notification, they closed off three neighborhoods and some of the police officers who patrolled were rude to residents. Discussion held. Mayor Hagan informed council the city office contacted the YMCA this afternoon and waiting for a response.
