

**CITY OF LYNDON
COUNCIL MEETING MINUTES
MONDAY, APRIL 27, 2020**

Mayor Brent Hagan called the Council Meeting to order at 6:00 p.m. The Pledge of Allegiance was recited. Those present: Susan Barto, Betsy Kramer, Kelly Kramer, Carla Nalley, Becky Ricketts, Mardy Sidebottom, Amy Stuber and City Attorney, John Singler.

A motion was made by Kelly Kramer seconded by Becky Ricketts to approve the minutes of the March 23, 2020 Council Meeting. Motion carried unanimously. A motion was made by Betsy Kramer, seconded by Carla Nalley to approve the April 20, 2020 Caucus Meeting. Motion carried unanimously.

The Treasurer's Report was given and will be filed for audit. Balance for April 1, 2020 was \$2,898,159.60.

MUNICIPAL ORDER 4-25-20 -Grant Application for Westport Middle Orchestra- A motion was made by Susan Barto to grant \$5,000 of the \$10,000 requested and consider granting more at a later date. Motion was seconded by Mardy Sidebottom. Mayor Hagan asked for a roll call vote. The following voted "aye": Susan Barto, Betsy Kramer, Kelly Kramer, Becky Ricketts, Mardy Sidebottom, Amy Stuber. Carla Nalley abstained. City Attorney, John Singler, informed council that Westport Middle will need to submit another application if they request more.

The Mayor announced the MRAP and Budget Hearing will be May 18th at 5:50p.m. with Council Mtg. to follow. If a web meeting is necessary, information will be sent out prior to May 18th.

OTHER BUSINESS:

As mentioned last month, Shakespeare in the Park may reschedule their performance in the fall, more information to come. Mayor Hagan announced the City made a deposit for the fireworks but event is still tentative.

Councilwoman Mardy Sidebottom asked about the financial submission with candidate filing papers. The Mayor informed council the documents are available on the Board of Elections website but offered to print out any needed forms. Discussion was held.




ADJOURNMENT:
